### **PERMITTED USES**

- » You MAY use my designs for commercial use up to 300 copies of the finished product.
- » You MAY use my designs to create your own digital products (e.g. digital scrapbook kit) that you sell to a customer for personal use as long as my designs are not more than 40% of the finished product. The final product must be finished (e.g. not a template) and must be in a flattened format. My original designs must never be sent to your customer.
- » You MAY use my designs to create other digital items that you give away for free on your newsletter or website ("freebies"), as long as my design is used as part of a composition, comprises less than 40% of the new item, and the freebie item is flattened in such a way that my original work cannot be easily isolated from the new composition.
- » You MAY use my designs to create client commissioned blog elements, website elements, banners and logos to sell to a customer for their personal use only. Your final design must be personalized to the individual customer and must be in a flattened format with a maximum of 72 DPI. My original designs must never be sent to your customer.
